Reports

Area Agency on Aging: George Losoya, Director of AAA/ADVRC, briefed the committee on the current state of the program, including the process of FY2024 Closeout and initial start for FY25 Planning Budgets due to the increase in Congregate Meals. Mr. Losoya presented a check received from Texas Veterans Commission in the amount of Three Hundred Thousand dollars to fund for Veterans' Assistance grant, as well as informing committees about the future Caregiver and Education Training Events. Mr. Losoya also notified the committee of an upcoming absence in six weeks for heart surgery.

<u>Housing</u>: Carmen Lim, Director of HAP, commended the staff for their hard work on the VASH program, highlighting its current success rate of 80% and the goal of achieving 100%. Ms. Lim also noted a 1% increase in the Utility Allowance for all counties. In terms of Fair Market Rent adjustments, Bell, Coryell, and Mills County will receive a 1% increase, while Hamilton, Lampasas, Milam, and San Saba County will see a 1% decrease. Additionally, she mentioned updates on the number of clients served by each county.

<u>Planning and Regional Services:</u> Planning and Regional Services: Uryan Nelson, Director of PRS, updated the committee on the current performance of the Regional Planning and Emergency Planning Services departments. Mr. Nelson informed the committee about the upcoming HSAC meeting scheduled for November 7 in Coryell County. Mr. Nelson also shared statistics on the 911 calls and texts received in September 2024 for each county within the CTCOG region. Additionally, Mr. Nelson provided an update on the Safe Streets and Roads for All (SS4A) with Invoice Tracker from July 2023 through September 2024. The committee expressed concern that some individuals might perceive DocuSign as a scam and recommended that the planning staff send an email notification to recipients before sending a DocuSign email.

Workforce Development Board: Susan Kamas, Executive Director of WFBCT, gave a speech about Judge John

Hull's contribution to Workforce Development and reminded the committee about the upcoming event. Ms. Kamas mentioned one of the award recipient stories who received assistance from Workforce Development.

<u>Workforce Solutions Central Texas:</u> Louis LeDoux, Chief Operating Officer of WFSCT, provided an update on regional unemployment rates, reporting that for the week ending August 31, 2024, the total number of UI claims filed reached 12,759, with an unemployment rate of 5%. Mr. LeDoux also updated the committee on the biggest hiring event called "Hiring Red, White & You", held on November 6,2024 at Lone Star Conference Center. Additionally, Mr. LeDoux informed the committee that 9,492 customers were served in September 2024, receiving a total of 25,138 services.

Executive Directors Report: Mr. Jim Reed, AICP, Executive Director of CTCO, reminded the committee that there will be no Executive Committee Meetings in November and December. An update was provided on the 911 District, with plans for Mr. Reed to meet the Executive Director of the Commission on State Emergency Communications (CSEC) on November 6, 2025, to discuss further plans. The goal is to present action steps and a timeline at the next Executive Committee Meeting in January.
