The Central Texas Council of Governments, Belton, Texas is soliciting qualified firms to conduct a **Joint** Land Use Study-Implementation (JLUS-I).

#### **General Information**

The Central Texas Council of Governments Planning and Regional Services hereinafter referred to as CTCOG serves as the planning organization for various services in the Central Texas area. The CTCOG serves a seven county area that includes the counties of Bell, Coryell, Hamilton, Lampasas, Milam, Mills and San Saba.

CTCOG is issuing a request for qualifications for firms to conduct the implementation phase of the recently completed Joint Land Use Study for the Fort Hood area. This study is funded through a grant from the Office of Economic Adjustment (OEA) with matching funds provided by participating entities. The scope of work is to plan for and initiate the JLUS recommendations outlined in the final Fort Hood JLUS document. The proposal timeline for the project is 18 months. #### Part I

#### **Selection Process**

The submittals will be evaluated by CTCOG staff. However, CTCOG reserves the right to select an independent review team for the purpose of RFQ evaluation should the need arise. The following considerations apply to the selection process:

- **A.** All submittals considered must be received on time and be responsive to the RFQ instructions.
- **B.** CTCOG staff will base their selection(s) on general qualifications, project knowledge and understanding, ability to serve, and background.
- **C.** Paper responses must be on 8 ½" x 11", 8 ½" x 14" or 11" x 17" only.
- **D.** Electronic responses must be formatted for 8 ½" x 11", 8 ½" x 14" or 11" x 17" output only.
- **E.** CTCOG will base final selection on the evaluation factors exhibited in the evaluation criteria (Part II of this document).
- **F.** It is the policy of CTCOG to pursue Historically Underutilized Businesses. However, the selection process will follow the weighted scoring criteria as exhibited in this RFQ.
- **G.** Final selections will be posted on the CTCOG website following successful contract negotiations.

- 7. The selected contractor must agree to comply with all applicable terms and conditions specified in the contract between CTCOG and O.E.A. (specifically Article VII Subcontracts) as well as all certifications, assurances, and forms required under CTCOG's procurement policy.
