#### **Guest Speakers & Presentations**

David Shaw, Texas Department of Emergency Services and LT. Richard Hoover, Texas Department of Public Safety were unable to present and will move their event to next month's meeting.

Andrea Pacheco, Texas Broadband Development Office, gave an in depth briefing on the needs of the region as far as broadband network coverage is concerned. Her presentation highlighted challenges such as speed differences, lack of coverage, and broadband map plan accuracy.

#### **Reports**

<u>Area Agency on Aging:</u> George Losoya, Director of AAA/ADVRC briefed the committee on the current state of the program, and upcoming events in the region. Mr. Losoya also briefly touched on the increase in the reimbursement rate for the Home Delivered Meal Costs, which is now \$6.46.

**Housing**: Carmen Lim, Director of HAP, advised the committee that the Housing Assistance Program (HAP) gave a brief summary of the previous month's activities for lease ups, inspections, and payments.

**Planning and Regional Services:** Uryan Nelson, Director of PRS, briefed the committee on the current performance of both the Regional Planning and Emergency Planning Services departments as well as sharing the most current updates on the Safe Streets for All (SS4A) project funding and progress.

**Workforce Development Board:** Susan Kamas, Executive Director of WFBCT, advised the committee of the current standings and ratings of several WFSCT programs including policy changes to the childcare program that will go into effect 10/01/2023.

<u>Workforce Solutions Central Texas:</u> Louis LeDoux, Chief Operating Officer of WFSCT, Louis LeDoux, Chief Operating Officer of WFSCT, briefed the committee on the standing of Texas UI claims for the region as well as the unemployment rates for the region as of 05/19/2023. The total UI claims filed for the week ending 07/01/2023 reached 16,873 and the unemployment rate rests at 4.6.

**Executive Directors Report:** Mr. Jim Reed, AICP, Executive Director CTCOG, briefed the committee on the need for a CTCOG representative for both state and national association events. He offered Mayor Debbie Nash-King as his choice to fill the vacant position, whom Dr. Yeonopolus, Chancellor, Central Texas College, made a motion to accept. Mrs. Stephanie O'Banion, Councilmember, City of Belton, second the motion. All in favor, none opposed. Mr. Reed also advised the committee that the next meeting will be held on July 27, 2023, at 12:00pm in the CTCOG Belton Offices.
