# **Consent Agenda**

A motion was made by Milam County Judge Steve Young to accept the minutes of April 11, 2019 and the respective expenditure report for April 2019. Hamilton County Commissioner Dickie Clary seconded the motion. All in favor, none opposed. A motion was made by Texas Municipal League Representative Mary Gauer to accept the following resolutions together; Resolution #05-19-HAP01 to Approve the Central Texas Council of Governments/Housing Division's Fiscal Year 2019 Annual Agency Plan, Resolution #05-19-ADMIN01 Authorizing Membership to Public Power Pool, and Resolution #05-19-PRS01 Authorizing Criminal Justice Program FY 2020 Funds. City of Killeen representative Otis Evans seconded the motion. All in favor, none opposed.

#### Reports

# **Area Agency on Aging**

Kerry Fillip, Directors of Area Agency on Aging stated 6 or the 7 Senior Town Halls are complete. The three main issues were: transportation, access to health care, and food and security. Aging was awarded an Elder and Venerable Adult Justice Program for \$300,000 and is an annual grant that must be applied for every year. The funds will be spent on staff salaries, equipment, and possible application software. With the grant two CTCOG divisions will be working together: Aging and Criminal Justice. Along with the grant it will require assistance of all first responders and Kerry along with the Emergency Service Program Manager, Jesse Hennage to create classes for police officers for TCOLE credits. Currently elder abuse awareness lags 20 years behind child abuse and domestic abuse. There are gaps in the system, no cohesive data, and inadequate training of first responders. The goal is developing a uniform data collection mechanism, conduct needs assessment and assist in establishing procedures and processes for better case management of victims' services.

# **Planning & Regional Services**

Jim Reed Executive Director stated Uryan Nelson, Planning & Regional Services Director would not be briefing as he had a family emergency. Jim explained that Homeland security was currently working on THIRA and stakeholder preparedness review and that there were grant workshops coming up in January and February available in every county. There were 6 counties scheduled for equipment refresh and map upgrades in the fall. NextGen 9-1-1 core services will be provided by Motorola's Vesta Solutions.

#### Housing

George Losoya, Housing Director stated there are 2,047 continuously leased families. September lease up had 264 applicants scheduled, 141 seen, and 123 no shows. The online waiting list was opened October 9-14, 2019 and took 2,926 applications.

# **Workforce Development Board and Workforce Center**

Jim Reed, Executive Director of CTCOG stated that Susan Kamas, Workforce Development Board Executive Director & Louis LeDoux, Interim Workforce Center Director would not be briefing as they were attending the rehearsal for the Workforce Annual Awards Luncheon.

Jim Reed, Executive Director stated there will future funding for various programs, State Association and Legislative update given.
