I. WELCOME AND INTRODUCTIONS:

II. PUBLIC COMMENTS:

• There were no public comments.

III. STAFF UPDATE:

• John Weber updated the SWAC on October air quality readings from stations in Killeen and Temple.

IV. ACTION ITEM: APPROVAL OF May 31, 2018 MEETING MINUTES:

 Mark Hyde moved to approve the May 31, 2018 minutes. Motion was seconded by Duane Huerra and passed unanimously.

V. ACTION ITEM: NOMINATION OF VICE CHAIR:

- Zoe Rascoe entertained the motion for nomination of Vice Chair. Bill Parry volunteered for the position.
- The motion was approved unanimously.

VI. ACTION ITEM: APPROVAL OF STERICYCLE CONTRACT PRICE ADJUSTMENT:

- Bill Parry and Noel Watson stated that Stericycle's service has not met standards in the past and would like to see the service improve before proceeding with the contract renewal.
- Zoe Rascoe entertained a motion to table this item until Sydnee Steelman speaks with a Stericycle Representative about these issues.
- Johnny Wagner motioned to table this item and vote on it electronically in the future so that CTCOG staff may have time to speak with a Stericycle representative. Motion was seconded by Jamie Duncan.

VII. DISCUSSION ITEM: TEMPLE HOUSEHOLD HAZARDOUS WASTE EVENT DATA REPORT:

- Sydnee Steelman informed the committee that a total of 605 vehicles came through the Temple HHW Event on September 29, 2018.
- Zoe Rascoe informed the group that further data was included in the meeting packet for review.

VIII. DISCUSSION ITEM: PRESENTATIONS BY APPLICANTS FOR FY2019 HHW EVENTS:

Representatives from each entity that submitted an FY2019 HHW Event application were given the
opportunity to give the committee information about their possible event and answer any questions

IX. ACTION ITEM: SCORING AND SELECTION OF HOUSEHOLD HAZARDOUS WASTE EVENTS FUNDING ALLOCATION FOR FY2019:

- Members individually scored each HHW Event application, then discussed funding allocations and dates for the events. The following list was the outcome of this discussion:
 - 2/23: Copperas Cove \$12,500
 - 3/16: Gatesville \$12,500
 - o 4/13: Hamilton \$18,000
 - o 6/29: Killeen \$10,000
 - o 9/2018: Temple Remaining Funds
- Zoe Rascoe entertained a motion for approval. The motion passed unanimously.

X. MEMBER COMMENTS/DISCUSSION

- Members would like to discuss issues with Stericycle at a meeting then vote electronically on the price adjustment.
- Staff was asked to look further into this, as the timeline might not work for the upcoming HHW Events and coordination with Stericycle.
