## **Staff Update**

## a) RSWMP Update

- The 2022-2042 RSWMP was approved by the CTCOG Executive Committee on October 28<sup>th</sup>, 2021 and submitted to TCEQ for review on November 9<sup>th</sup>, 2021
- TCEQ returned the plan in December with several comments following their initial review. AZB assisted staff with addressing their comments and a revised plan was submitted in early January 2022.
- TCEQ reviewed the plan again and requested several editorial changes in February 2022
- On March 29<sup>th</sup> CTCOG received notice from TCEQ that they had completed their review of the RSWMP and given preliminary approval to the plan.
- Volume I will be presented to the TCEQ commissioners for adoption during an upcoming agenda and Volume II will be put before the executive director for approval.
- Staff will notify the SWAC of any further updates as well as when the plan is put on the agenda for adoption.



1. Call to Order: Duane Herrera called the meeting to order at 10:01 am.

2. Public Comments: No comments were made by the public.

3. Staff Update: Federal and State Updates; Air Quality.

James McGill shared that since the last meeting was so recent, there were no new federal or state updates to share with the committee. Air Quality for the month of September was 67 ppb at the Temple station and 71 ppb at the Killeen station.

**4. Action Item:** Approval of the September 30, 2021 meeting minutes.

Zoe Rascoe made a motion to approve the September 30, 2021 meeting minutes, seconded by Commissioner Johnny Wagner; the motion passed unanimously.

**5. Discussion and Action Item:** Regarding Approval 2022-2042 Regional Solid Waste Management Plan (RSWMP).

Michael Carleton from Arredondo, Zepeda & Brunz informed the committee of some changes to the draft RSWMP based on comments from Bill Parry and Fort Hood. Mr. Carleton stated that the revisions made did not change any of the overall goals or objectives of the plan. Marcie Seele with Belton stated that there was an error in the list of services they provide. Other members noted that the employment growth rate seemed low based on what's going on now. Mr. Carleton said that he would conduct a sensitivity analysis to address a potential higher growth rate in the region.

Zoe Rascoe made a motion to approve the 2022-2042 Regional Solid Waste Management Plan with the noted changes from the meeting, seconded by Commissioner Johnny Wagner; the motion passed unanimously.

**6. Discussion and Action Item:** Regarding approval of the FY22-23 Solid Waste Application & Funding Plan.

James McGill explained to the Committee that the FY22-23 Solid Waste Application & Funding Plan describes how CTCOG will use the funds for the biennium and details the budget for the contract period. Zoe Rascoe asked what was included in the "Other" category. Mr. McGill replied that a large portion was for office/administration costs.

Noel Watson made a motion to approve the FY22-23 Solid Waste Application & Funding Plan, seconded by Marcie Seele; the motion passed unanimously.

7. Discussion and Action Item: Regarding extra Solid Waste Coordination dollars for Temple HHW event.

James McGill explained that even though these funds (\$2,105) were allocated at the last SWAC meeting, that allocation was not on the official agenda. Mr. McGill stated that staff requests this formality so that there is official record of allocating leftover Solid Waste Coordination dollars to the Temple HHW event.

Commissioner Johnny Wagner made a motion to confirm the allocation of extra Solid Waste Coordination dollars in the amount of \$2,105 to the Temple HHW event, seconded by Justin Brantley; the motion passed unanimously.

8. Discussion and Action Item: Regarding FY22 HHW event dates.

Duane Herrera explained that following the selection of FY22 HHW events and the allocation of funds for those events at the September 30 meeting, staff forgot to ask the Committee to determine event dates in the spring. Mr. Herrera recommended a plan for scheduling the selected events. Several members made comments about when their event was landing on the schedule. The committee reached a consensus on the following schedule listed below:

- City of Temple October 23, 2021
- City of Nolanville (Tire Event) November 4-7, 2021
- City of Kempner February 26, 2022
- City of Gatesville March 26, 2022
- Milam County April 9, 2022

- City of Killeen May 14, 2022
- Bell County (Tire Event) August 2022

Noel Watson made a motion to approve the schedule for FY22 HHW event dates, seconded by Marcie Seele; the motion passed unanimously.

### 10. Member Comments:

James McGill introduced Dominic Elizondo, CTCOG's new Planner for Economic Development. Duane Herrera encouraged the SWAC to submit flyers to their events to James in advance so he could share them with the community and raise awareness for all of them.







- 10% of attendees brought tires










## City of Kempner 2022 HHW Event

- 7% of attendees brought tires










## City of Gatesville 2022 HHW Event

## **Clean Earth Contract Addendum**

Clean Earth notified CTCOG staff prior to the Gatesville HHW event that an addendum was needed to increase the price of supplies and materials listed in the original contract. The main reason for the increase in cost is due to the global supply chain issues that have driven prices up.

Because this affects the cost of events and involves financial numbers, staff is seeking SWAC approval for the addendum prior to agreeing to any changes.

The proposed addendum is included in your meeting packet for review along with a comparison to prices in the original contract.

<u>Action Item:</u> Approve the addendum to Clean Earth's contract to provide HHW disposal services for the increase of supply prices.

## **FY22 Solid Waste Earned Interest**

Per our contract with TCEQ, all Solid Waste grant funds are placed in interested bearing accounts when received. ## **FY23 HHW Event Call for Applications**

CTCOG receives grant funds from TCEQ through the Solid Waste grants program for regional coordination and planning and as pass-through funding for various implementation projects. Historically the SWAC has decided to use all implementation funds for Household Hazardous Waste events throughout the region.

Staff brings this item before the committee each year to determine the use of funds for the following fiscal year and to provide an opportunity to comment on the required application for implementation funds (HHW events or other as determined by SWAC).

If SWAC chooses to utilize Solid Waste Implementation funds for HHW events as in previous fiscal years, a call for applications will be held during summer 2022 to select which entities will host an event in FY23 (October 2022 through September 2023). Entities wishing to host an HHW event will be required to fill out an application and present their proposals to the committee at the September/October 2022 SWAC meeting.

Attached to this meeting packet is a draft application. Staff is requesting feedback and approval on the call for applications and the FY23 application period. The call for FY22 applications was open for 44 days and ran from July 1<sup>st</sup> through August 13<sup>th</sup>, 2021.

<u>Action Item:</u> Determine Use of Implementation Funds for FY23, approve the project application and select dates for the application period.

### Household Hazardous Waste Events – Fiscal Year 2023

The Central Texas Council of Governments (CTCOG) Solid Waste Advisory Committee (SWAC) is requesting applications from cities or counties interested in hosting a Household Hazardous Waste (HHW) collection event during FY 2023. Fiscal Year 2023 begins on September 1, 2022.

This application is due back to CTCOG staff no later than August 15, 2022. The SWAC will vote to select events at their next meeting, <u>tentatively</u> scheduled for September 15, 2022 at the CTCOG offices. Be prepared to have a representative present to answer questions regarding your site or your ability to contribute funds or labor. Note that on page three of the application form is a selection of background information and lessons learned.

## **Information from past events:**

Past CTCOG contribution towards cost: \$10,000 - \$20,000
 Past turnout for urban area (Killeen or Temple): 350-500+ cars
 Past turnout for rural area (Hamilton or Gatesville): 150-300+ cars
 Past total cost for urban events: \$30,000 - \$50,000+
 Past total cost for rural events: \$20,000 - \$35,000
 Cost for tire trailer provided by contractor: \$4000 (approximate)
 Cost for electronics vendor on site: Depends on vendor / contract

Newspaper advertising – depends on local paper classified ad rates. Ads are most
effective in the community where the event takes place, less so with increasing
distance.

Most effective advertising: local newspaper, water bill inserts, church announcements, community billboards.

### **Lessons learned:**

- One way traffic works best having people enter and exit through a single entry point can cause traffic jams, confusion to the drivers, and may increase the risk of a car striking a pedestrian
- Combined events (HHW in conjunction with a city-wide clean-up) may increase confusion
  to the public regarding acceptable items for disposal, times, or locations. Staff or
  volunteers will have to identify the visitor's purpose and direct them to the correct
  location. It may require traffic to cross paths or have to merge back in line and can make
  data collection difficult if people are being counted that aren't bringing hazardous waste.
  However, it can work given the appropriate location. If you are considering this, please
  contact your solid waste coordinator for more information.
- Maximize the use of volunteers to help direct traffic, take surveys, hand out promotional items, unload tires, etc. The quicker a car can be received, surveyed, unloaded and moved out, the happier your residents are going to be. Traffic won't back up, tempers won't flare, and you just have a better flow of cars through the site.
- Brief the volunteers and paid employees well before the scheduled opening time. That
  helps everyone understand how cars will be directed to flow through the site, and what
  their part will be. Also, you can brief them on the safety hazards involved with moving
  vehicles, hazardous chemicals, heat exhaustion, etc.

- Expect people to begin arriving at the event at least one hour prior to the posted start time, especially in the rural areas.
- Volunteers or paid staff are a necessity.
- Please provide access to bathrooms.
- If your entity is selected, please reserve the event location a few days in advance as so that contractors can set up their stations before the event date.

#### **HHW Vendor Contract Renewal**

#### **Styrofoam Collection Program**

Staff was asked last year about a Styrofoam recycling/collection program. Styrofoam is not something that Clean Earth currently accepts at our regular HHW events.

There is a company in Waxahachie, Dart Corp, that will recycle Styrofoam that is brought to them and a group in Waco that holds several Styrofoam collection events throughout the year.

Staff is willing to explore this idea further if there is interest from the committee in hosting or holding Styrofoam collection events.
