### **Staff Update**

### a) RSWMP Update

- The 2022-2042 RSWMP was approved by the CTCOG Executive Committee on October 28<sup>th</sup>, 2021 and submitted to TCEQ for review on November 9<sup>th</sup>, 2021.
- CTCOG responded to two rounds of TCEQ comments in January and February 2022.
- On March 29<sup>th</sup> CTCOG received notice from TCEQ that they had completed their review of the RSWMP and given preliminary approval to the plan.
- Volume I will be presented to the TCEQ commissioners for adoption during an upcoming agenda and Volume II will be put before the executive director for approval.
- CTCOG was informed in August that TCEQ needs to amend the TAC rules before the regional plans can be adopted. This process can take up to 12 months.
- All 24 regional plans were posted on TCEQ's website on August 19<sup>th</sup> for public comment through September 20<sup>th</sup>. CTCOG notified the public of this opportunity for comment through our website and social media channels.
- Staff will notify the SWAC of any further updates as well as when the plan is put on the agenda for adoption.



**1. Call to Order:** Bill Parry called the meeting to order at 10:00 am.

2. Public Comments: No comments were made by the public.

3. Staff Update: RSWMP Update; Federal and State Updates; Air Quality.

James McGill provided the committee an update on the Regional Solid Waste Management Plan (RSWMP) approval process. Mr. McGill stated that TCEQ provided two rounds of comments and also preliminarily approved the RSWMP on March 29<sup>th</sup>, 2022. Mr. McGill explained that the final step is for the TCEQ Commissioners and Executive Director to formally approve the full plan. Mr. McGill shared that Earth Day was coming up and also a link to the EPA's National Recycling Strategy. Air Quality for the month of March was 67 ppb at the Temple station and 69 ppb at the Killeen station.

**4. Action Item:** Approval of the October 14, 2021 meeting minutes.

Commissioner Johnny Wagner made a motion to approve the October 14, 2021 meeting minutes, seconded by Justin Brantley; the motion passed unanimously.

#### **5. Discussion Item:** Regarding update on FY22 HHW Events.

James McGill provided an update on the survey results from the Temple, Kempner, and Gatesville HHW events as well as the Nolanville Scrap Tire event. Mr. McGill noted the upcoming Bell County Scrap Tire event, Milam County HHW event, and Killeen HHW event. Representatives from Temple, Kempner, and Gatesville also provided comments about their events.

**6. Discussion and Action Item:** Regarding addendum to Clean Earth contract for cost increases.

James McGill explained that Clean Earth had requested an addendum to their current contract to increase the price of supplies for future HHW events that they conduct. Mr. McGill stated that Clean Earth's justification was supply chain issues and the recent inflation in the country.

SWAC members discussed the proposal and whether there was an option to say no to the price increases.

Mark Hyde made a motion to approve the Clean Earth contract addendum for supply cost increases; seconded by Paul Daugereau; the motion passed unanimously.

7. Discussion and Action Item: Regarding FY22 Solid Waste earned interest.

James McGill stated that CTCOG's implementation funds have earned interest over the course of the fiscal year and that the SWAC needed to decide how to use those funds. Mr. McGill noted that staff's recommendation is to roll the funds over to FY23 to be included in the budget for FY23 implementation projects.

Duane Herrera made a motion to roll the FY22 earned interest over to FY23 and add it to the implementation budget, seconded by Justin Brantley; the motion passed unanimously.

**8. Discussion and Action Item:** Regarding Call for Applications for FY23 HHW events.

James McGill noted several changes to the application for FY23 and explained the process for submitting project requests and receiving funding from the SWAC.

The SWAC discussed using implementation funds for projects other than just HHW. Staff stated that other projects could be funded as long as there is an application process, and those activities are included in the plan CTCOG sends to TCEQ every two years detailing what kinds of projects we will be conducting.

Paul Daugereau made a motion to approve the FY23 Call for Applications packet and schedule, seconded by Mark Hyde; the motion passed unanimously.

9. Discussion Item: Regarding HHW Vendor contract renewal.

James McGill stated that the original term on CTCOG's contract with Clean Earth is set to end in January 2023 and that staff wanted to bring up the idea of getting a new contract or proposal. Mr. McGill explained that

the current contract is set to auto renew for another three year period and that staff is interested in updating the proposal and contract with Clean Earth due to all of the changes within the last three years. The committee discussed this idea and recommended that staff talk to Clean Earth about the possibility addressing a new agreement for HHW collection services.

**10. Discussion Item:** Regarding regional Styrofoam collection program.

James McGill shared an email from last year requesting the SWAC to consider a regional Styrofoam collection program similar to an existing one up in Waco. The group discussed the idea and direct staff to inquire further about the program in Waco and where a potential collection point could be located.

**11. Discussion Item:** Regarding review of Scrap Tire Facility application.

James McGill shared with the Committee that CTCOG was notified of an application for a new scrap tire facility near Gatesville. Mr. McGill stated that the application was brought to the SWAC for their review and notice.

#### 12. Member Comments:

Mark Hyde requested that the upcoming Bell County Scrap Tire event and Milam County HHW event flyers be sent out to the group.







- 23% of attendees brought oil/antifreeze.










### Killeen County 2022 HHW Event

### **Solid Waste Earned Interest**

Per our contract with TCEQ, all Solid Waste grant funds are placed in interested bearing accounts when received. Any interest earned by CTCOG through those accounts may be used in any budget category including implementation projects. Currently, there is \$344.31 in Earned Interest that is available for use. These funds can be spent in the current fiscal year (FY22), or they may be rolled over to the next fiscal year (FY23) for use then.

Staff anticipates that additional interest will be earned by the account throughout FY23. Historically the SWAC has added these funds to implementation projects. Staff requests that SWAC determine how CTCOG should utilize current and future earned interest funds.



# **HHW Vendor Contract Renewal**

CTCOG and Stericycle Environmental Solutions (now Clean Earth) signed a contract on January 28, 2020 to provide household hazardous waste services to CTCOG for a three year period. The contract is set to renew for another three year period if no action is taken.

# **Alternate Use of Implementation Funds for FY24-25**

CTCOG receives funding from TCEQ (dependent on the legislature) every year to run the Solid Waste Grants program. This program runs on a two year cycle with the current period covering FY22-23. CTCOG must submit an application and funding plan at the beginning of each biennium to TCEQ that details how and what we will spend solid waste funds on for the two-year window.

Over the past 10-15 years, the SWAC has consistently directed CTCOG to utilize the Implementation dollars received each biennium for Household Hazardous Waste (HHW) events since there is a strong need for that in our region. However, the Implementation dollars we receive can be used many other ways.

Here is a short list of programs and projects that other COGs use their Implementation dollars for:

- Local Enforcement Projects/Programs (e.g. surveillance equipment, vehicles, illegal dumping enforcement campaign, etc.)
- Recycling program equipment (e.g. balers, forklift, recycling trailer, etc.)
- Educational programs (e.g. ISD recycling education)
- Collection events (e.g. tires, e-waste, bulky waste, litter)
- Miscellaneous items (e.g. recycling/trash bins, specialized collection bins)
- Local Government waste management plans (create new or update)
- Composting/food scrap program
- Waste Management's At Your Door Service\*
