#### Oath of Office

The oath of office was administered to Mayor Nathan Fuchs, City of Cameron, and Commissioner Henry Hubnik, Precinct 1, Milam County, as representatives on the Executive Committee Board.

### **Public Comment**

There was no Public Comment.

#### **Consent Agenda**

A motion was made and seconded to accept the Consent Agenda, which included the August 2024 Expenditure Report and the August 2024 Meeting Minutes. All in favor, none opposed.

#### **Action Items**

A motion was made and seconded to approve Resolution 08-24-PRS001, which sought to authorize the State Homeland Security Program (SHSP) Central Texas Council of Governments Planning Grant FY 2025 Funds. All in favor, none opposed.

#### Reports

<u>Area Agency on Aging:</u> George Losoya, Director of AAA/ADVRC, briefed the committee on the current state of the program and the success of the Coryell County Senior Expo. He also updated the committee on the grant awarded to the AAA and CTCOG by the Texas Veterans Commission Fund for Veterans Assistance. Additionally, Mr. Losoya informed the committee of the upcoming Bell County Senior Expo and the Caregiver Conference that AAA will hold in November 2024.

<u>Housing</u>: Mr. Jim Reed presented the committee with the numbers of the clients served in the past month in the CTCOG region. Mr. Reed informed the committee that the arrears have been completed paid to KHA landlords, as well as the completion of the amnesty period provided to KHA clients who failed to transfer.

<u>Planning and Regional Services:</u> Mr. Reed updated the committee on the Hazard Mitigation Plan, which is nearing completion, and the State Emergency Radio Infrastructure Grant, which has been preliminarily approved. Mr. Reed also provided updates on the Peace Officer training classes held in the previous months, as well as the 911 call and text data for the month of July. Additionally, Mr. Reed provided an update on the Safe Streets and Roads for All Grant.

Workforce Solutions Central Texas: Louis LeDoux, Chief Operating Officer of WFSCT, informed the committee

about the recent award of the American Legion National Award for Employment Services. Mr. LeDoux provided an update on regional unemployment rates, reporting that for the week ending August 16, 2024, the total number of UI claims filed reached 13,453, with an unemployment rate of 4.1%. He also updated the committee on the six hiring events held in July. Additionally, Mr. LeDoux informed the committee that 10,384 customers were served in July 2024, receiving a total of 27,643 services.

**Executive Directors Report:** Mr. Jim Reed, AICP, Executive Director of CTCOG, delivered a presentation to the Executive Committee outlining staff's recommendation to transition from the State 911 system, governed by the Commission on State Emergency Communications (CSEC), to a 911 District. Mr. Reed explained how 911 systems are funded and assured the committee that the region's service fees are sufficient to support the transition. Mr. Reed emphasized the greater flexibility that a 911 District would offer and discussed the optimal timing for making the transition.

Mr. Reed further informed the committee that the CSEC Executive Director had extended an offer of State General Revenue funds to assist with the transition if CTCOG waits until after the next legislative session. Mr. Reed detailed the process of establishing a 911 District and explained that staff recommends the committee authorize the CTCOG Executive Director in September to begin preparing the necessary documentation for the creation of the Central Texas Emergency Communications District (CTECD), with a target cutover date prior to the end of calendar year 2025.

Mr. Reed then opened the floor for discussion and questions from the committee.

**WHEREAS**; in July 2022 the Central Texas Council of Governments was awarded funding through the Safe Streets and Roads For All grant program to develop a regional comprehensive Safety Action Plan; and

**WHEREAS;** the Central Texas Council of Governments contracted with Kimley Horn and Associates to develop the regional Safety Action Plan; and

**WHEREAS**; part of Kimley-Horn's scope of work is to identify high quality regional safety implementation projects and develop grant application supporting materials for those projects; and

**WHEREAS;** Kimley Horn and CTCOG staff identified an initial list of safety projects in April 2024 to begin developing preliminary support material for; and

**WHEREAS**; Kimley Horn and CTCOG staff have conducted further outreach and identified an updated list of 109 safety projects in September 2024; and

**NOW, THEREFORE, BE IT RESOLVED** that the Central Texas Council of Governments approves the attached Revised SS4A Project Selection List.

### **SS4A Project Selection Summary Explanation**

#### September 2024

CTCOG and KTMPO have been jointly developing the Central Texas Roadway Safety Action Plan with a planning grant from the USDOT Safe Streets and Roads for All (SS4A) program. The Central Texas Roadway Safety Action Plan will identify and prioritize safety-focused project and policy recommendations that are intended to reduce fatalities and serious injuries on Central Texas roadways. Plan development began in September 2023 and has included extensive safety data analysis, stakeholder outreach, and public engagement so far. From the initial round of input and follow up engagement through Summer 2024, CTCOG and KTMPO have identified 109 safety project opportunities across the region, as well as numerous policy-focused opportunities.

As part of plan development, CTCOG and KTMPO are assisting member agencies in identifying high-impact projects and supporting preliminary project development so that agencies can submit these project opportunities for potential grant funding. Based upon review of identified project opportunities, CTCOG and KTMPO have prepared final recommendations for high-impact projects that align with stakeholder feedback and would be expected to score well for SS4A Implementation grants, TxDOT Highway Safety Improvement Program (HSIP) Off-System grants, or other similar state and federal funding programs. The attached project selection slides and project information matrix both summarize relevant data about all 109 identified projects and the reasons for their selection for various project and grant application development pathways. Data points in the project information matrix that support justification for selection are shown in bold text for emphasis.

Projects identified for the SS4A Implementation track were selected because they each would include FHWA-approved safety countermeasures, are located along corridors with a high fatal and serious injury crash rate, and are also located in underrepresented communities as defined by USDOT. Projects identified for the HSIP Off-System track were selected because they each would include TxDOT-approved safety countermeasures, are located along off-system corridors with multiple fatal or injury crashes over the analysis period (2018-2022), and are expected to address crash types that TxDOT has prioritized for the region, including roadway departure, intersection, and pedestrian crashes. Projects identified for other grant programs were selected based on tying individual stakeholder needs to other relevant grant opportunities so that all stakeholders who have met with CTCOG and KTMPO throughout the plan development process would have an opportunity to receive continued project development support.
