# **Federal and State Legislative Updates**

## **TxDOT Section 5310 Funding Stakeholder Workshops**

Every two years the Texas Department of Transportation (TxDOT) accepts applications for 5310 program funding in early February. Before the Call for Projects, the Public Transportation Division (PTN) provides Public Involvement (PI) Workshops to get public input in 17 districts statewide. PI Workshops allow stakeholders (elderly, individuals with disabilities, and their advocates) to have a voice as to what is working in their area and what the unmet needs are. Each TxDOT District will be holding an entirely virtual workshop throughout early December 2022 and January 2023. Meeting link and registration details will be publicized prior to meetings for Districts that cover the CTCOG region. The Bryan District workshop covering Milam County is scheduled for Dec.6, 2022, 1:00-3:00 PM, and the Waco and Brownwood District workshops covering Bell, Coryell, Hamilton, Lampasas, Mills, and San Saba counties are scheduled for Dec.12, 2022, 10:00 AM-12:00 PM. ## **USDOT Thriving Communities Program**

The USDOT Thriving Communities Program (TCP) allows USDOT selected technical assistance providers to provide technical assistance and capacity building support to communities that may lack the staffing or technical expertise to scope, fund, and develop infrastructure projects. The TCP will provide two years of in-depth assistance to selected communities to help them plan and develop comprehensive transportation, housing, and community revitalization activities. MPOs, cities, counties, and transit agencies are eligible to submit letters of intent for this program; Deadline to submit is Dec.6, 2022. To read the guidance, click here!
